DECREE NO. 01 / 2012

Gubernatorial decree on the Establishment, Structure, Powers and Functions of City or Municipal Council of Malakal City

In accordance with the Council of Ministers' resolution No. (58) Dated 25th / November 2011 read together with article (53), (57) and (63) of the Local Government Act 2009, I Major Gen. Simon Kun Puoch Governor of Upper Nile State do hereby decree the full establishment, Structure, Powers and the Functions of the City or Municipal Council of Malakal City as follows:-

1. Powers and Functions

- Be responsible for Security, maintain of Law and Order in the City and execute policies & by-law enacted by Legislative Council.
- Mobilize and organize the general public to play an effective role in service delivery and development in the Municipality.
- Be responsible for the all Taxes in the Municipal Council of Malakal City.
- Ensure safe custody of all City or Municipal Council records and Funds.
- Coordinate Government, Non-Governmental Organizations (NGOs), Private and Community activities and functions in the City or Municipal Council.

2. Local Sources of Revenue within the City Council or Municipality shall be from the following Taxes and Local rates:

- Council property tax
- Council land tax
- Council Sales Tax
- User Service charges
- License fee
- Administrative fines
- Royalties
- Permits
- Contract fees
- Auction fees

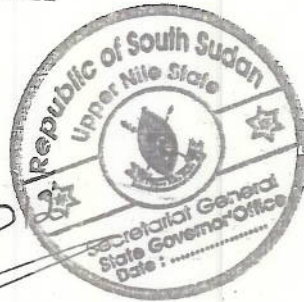
